ARTICLE I – NAME

ARTICLE III – PURPOSE

This corporation is a RELIGIOUS CORPORATION and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes.

The purpose for which the corporation is organized is to establish a place worship, study, and practice for Buddhist members; to proliferate to teachings of the Buddha; to practice a life style of compassionate non-violence, of mindful consciousness as the underlying foundation for the spiritual and insightful life of the Buddhists; to promote and encourage the maintaining of the five precepts, not to kill, not to steal, not to engage in sexual misconduct, not to lie, not to partake in substance abuse, in order to build happiness and peace for the individuals, the family, and society.

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for **religious** purposes and which has established its tax exempt status under Internal Revenue Code section 501 (c)(3)
