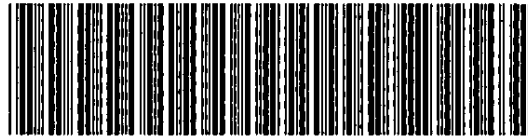

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

Article I - Name

The name of the corporation shall be: Helplight Charities Inc.

Article II - Principal Office

The principal place of business of this corporation shall be: 312 Fifth Street Jupiter, FL 33458

Article III - Purpose

The purpose for which the corporation is organized is: to establish a charity for collection and distribution of donations such as products, financial aid, general help that might be needed in the community. Monies or products donated or collected would be for non-profit use only for re-distribution to a needy cause. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


Article VIII - Supplemental Provisions/Information

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
