# HARDEE COUNTY GUN CLUB, INC. (a Florida corporation not-for-profit)

Charles C. "Chip" Knight, III, incorporator of a corporation not for profit under Chapter 617 of the Florida Statutes, hereby adopts the following articles of incorporation.

#### ARTICLE I. NAME

The name of the corporation is **HARDEE COUNTY GUN CLUB, INC.** 

#### ARTICLE II. PURPOSES AND POWERS

The purposes and objections of the corporation are such as are under Chapter 617 of the Florida Statutes, for the purpose of encouraging and monitoring shooting sports, promoting gun safety and awareness, and keeping current with existing laws on the books and new laws as approved by the State of Florida that apply to guns and ammo. It shall further be the purposes and objections of the corporation to develop and promote characteristics of honesty, good fellowship, self-discipline, and team play which creates good sportsmanship, and for any other lawful purpose under the laws of the State of Florida. These, along with community participation, will create true patriotism among the members.

## ARTICLE III. ADDRESS

The street address and mailing address of the corporation in the State of Florida is 130 West Main Street, Wauchula, Florida 33873, and the mailing address of the corporation is 130 West Main Street, Wauchula, Florida 33873.

## ARTICLE IV. INITIAL OFFICERS

#### ARTICLE VII. LIABILITY

Every director and officer of the corporation shall be indemnified by the corporation against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him or her in connection with any proceeding to which he or she may be a party, or in which he or she may become involved, by reason of his or her being or having been a director or officer of the corporation, whether or not he or she is a director or officer at the time such expenses are incurred, except in such cases where the director or officer is adjudged guilty of

willful malfeasance or misfeasance in the performance of his duties; provided that, in the event of any claim for reimbursement or indemnification hereunder based upon a settlement by the director or officer seeking such reimbursement or indemnification, the indemnification herein shall apply only if the Board of Directors approves such settlement and reimbursement as being in the best interest of the corporation. The foregoing right of indemnification shall be in addition to and not exclusive of, all other rights to which such director or officer may be entitled.

## ARTICLE VIII. AMENDMENT OF ARTICLES OF INCORPORATION AND BY-LAWS

The corporation reserves the right to amend, alter, change or repeal any provision contained in these articles of incorporation in the manner now or hereafter prescribed by law. Each amendment submitted to the board members for approval must be approved by majority of the board members entitled to vote thereon.

#### ARTICLE IX. NON-PROFIT CHARACTER

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its trustees, officers, or other private Persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes and set forth in this document.

### ARTICLE X. REGISTERED OFFICE AND AGENT

The corporation hereby designates as its registered office 424 West Main Street, Wauchula, Florida 33873, and its registered agent, **KENNETH B. EVERS**, at such address for service of process.
