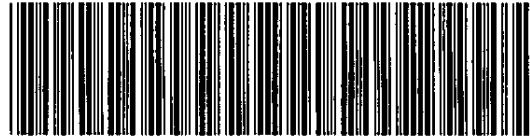

**Purpose & Dissolution:**

The Southeastern Regional Dragon Boat Association organization is organized exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Our activities include introducing and teaching/educating our sport to all ages, hosting various dragon boat Regional Championships; fostering national and international amateur sports competition; offer various clinics and courses on dragon boat racing, drumming, coaching and festival organization, as well as award scholarships to youth for programs and events.

The officers and directors of the organization devote 25% of their time per week to communication with members and organization of the SRDBA and its activities.

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
