

Purpose

The purpose of this corporation is to win souls to Jesus Christ though local, nationwide and worldwide ministries. This corporation is organized exclusively for charitable and religious purposes within the meaning of section 501 (c) (3) of the Internal Revenue code of 1954 (or corresponding provision of any future United States !Internal Revenue Law), including for such purposes the espousal of the gospel of Jesus Christ and propagation of the Christianity and Christian precepts. No part of the net earnings of the corporation shall inure to the benefit of, or be disstribured to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing and distribution of statements) and political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any further United States Internal Revenue Law).
