In response to your letter I note that the name of the proposed corporation includes the phrase "A Florida Not For Profit Corporation" which clearly meets the requirements of Section 617.0401, Florida Statutes, in that it has the word corporation in it. Secondly, you apparently do not believe that corporations can have owners or members, which appears to be directly contradicted by Section 617.0601. The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation laws of the State of Florida, do hereby certify:

# ARTICLE I

The name of the corporation is Bay County Swim Club, a Florida Not for Profit Corporation.

The principal place of business and mailing address of the corporation is 1926 W. 23<sup>rd</sup> Street,

Panama City, Bay County, FL 32405.

# **ARTICLE II**

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The primary purpose of the Corporation shall be the furthering of fitness and healthy lifestyles by providing swim and triathlon training, education, competitions, coaching, and related services, but the purposes are not limited to this so long as they are consistent with the other provisions of these articles

# **ARTICLE III**

#### **ARTICLE IV**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### <u>ARTICLE V</u>

The street address of the initial registered officer of this corporation is 565 Harrison Avenue, Panama City, Florida, 32401, and the name of the initial registered agent of this corporation at that address is Jeffrey P. Whitton.



# **ARTICLE VI**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
