**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SUNTREE VIERA ONE OWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1002, Florida Statutes, this Florida not for profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I is hereby restated as follows:

**ARTICLE I
NAME**

The name of this corporation shall be **BREVARD MEDICAL CITY ONE OWNERS ASSOCIATION, INC.** ("Association"). The terms contained in these Articles of Incorporation ("Articles") shall have the same meaning as set forth in the Declaration of Condominium of Brevard Medical City One, formerly known as Suntree Viera One (the "Declaration") unless otherwise defined herein.

2. The Document Number of this corporation is N14000009621.
3. The foregoing Amendment was adopted by the unanimous consent of the Board of Directors of the Corporation on this date in the manner prescribed by the Florida General Corporation Act.
