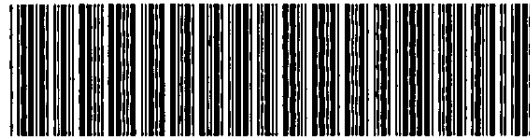

**ARTICLES OF INCORPORATION**  
**OF**  
**KIDS CONQUERING SICKLE CELL DISEASE FOUNDATION, INC.**

**A NON-PROFIT CORPORATION**

The undersigning incorporator, in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

**ARTICLE I :** The name of this corporation is Kids Conquering Sickle Cell Disease Foundation, Inc.

**ARTICLE II :** The principle place of business and mailing of this corporation shall be:

Mailing : 5465 CREPE MYRTLE CIRCLE, KISSIMMEE 34758

**ARTICLE III :** The specific purpose for which this corporation is organized are to:

- I. Dedicate with compassion to provide education, advocacy and outreach to improve the quality of life for children and families living with Sickle Cell Disease and other life threatening blood disorders.
- II. Collaborate and endure a network with other community organizations, health care providers, and the general public to increase public awareness and expand supportive services to eliminate negative social, psychological and economic impact often associated with sickle cell.
- III. Sponsor outreach to improve diagnostic methods for detecting, treating and researching for an ultimate cure for Sickle Cell Disease.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

**ARTICLE IV :** The manner which the directors are elected or appointed are as follows:

Upon the distribution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 ( c ) ( 3 ) of the Internal Revenue Code or shall be distributed to the federal government, or shall or local government, for public purpose. Such distribution shall be made in accordance with all appliance provisions of the laws of this state.

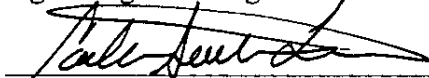
No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporations shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors or trustees, officers or other private persons, Except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose of these Articles.

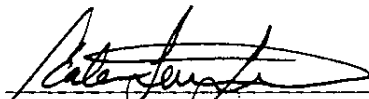
Notwithstanding any other provision of these Bylaws, this corporation shall not carry on activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of Internal Revenue Code, or (b) by corporation, contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

**ARTICLE X:** The effective date of the Article of Incorporation for Kids Conquering Sickel Cell Disease Foundation, Inc. shall be October 5, 2014.
