

Dear Ms. Dickey,

I am enclosing the documents you returned to me regarding the new corporation for the Plantation Junior Women's Club where we changed Woman's to Women's (with an "e" instead of an "a"). As I explained on the telephone today, the two entities are the same people, we just want to re-do all of our corporate filings so we can file for tax-exempt status with the IRS. Since we were originally approved in 1960, much of our original documentation has been lost or IRS regulations have changed so much that we need to re-do everything anyway. We also wanted to change the name to Women's regardless of the IRS situation, but it just seems easier to start anew.

I spoke with you on the phone today and you indicated I should send the documents back to you with a note describing our conversation.

## **ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit) (Florida)

### **ARTICLE I NAME**

The name of the corporation shall be: Plantation Junior Women's Club, Inc.

### **ARTICLE II PRINCIPAL OFFICE**

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is: to promote the development of its members in intellectual endeavor, cultural interest, social fellowship, and community service within the City of Plantation. The membership shall consist primarily, but not exclusively of, women living in Plantation, Florida. The club will be organized as a non-profit corporation and shall be non-political and non-sectarian. In addition to social activities, which include holiday dinners, social outings and other member gatherings, another specific objective shall be the promotion of the Plantation Junior Woman's Club Foundation, Inc., a non-profit Florida corporation that is a designated 501(c)(3) corporation by the IRS whose purpose is to raise, receive, and administer funds in the City of Plantation and to raise funds for donation to the Make A Wish Foundation of South Florida, Inc.

**ARTICLE IV MANNER OF ELECTION** The Officers and directors are elected annually at the March meeting by a vote of the membership.

#### **ARTICLE VI EARNINGS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### **ARTICLE VII DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


