## ARTICLE III: PURPOSE OF CORPORATION:

To engage in teaching, training and informing individuals about positive educational solutions to everyday situations. We desire to assist individuals with outlets of hope based upon a Christian educational foundation. We believe in a Christian approach to success. By strengthening and equipping the Physical, Mental and Spiritual being, we can be used as a viable source to help individuals in becoming Positive Productive Members of Society. Our services provide a range of educational and developmental skills to include but not limited to Educational Structures, Mentorship Programs, Leadership Instructions, Interaction Activities, Community Outings and various Social Gatherings. With a Christian approach, we can aid in providing a sense of direction, stability, discipline, and purpose for individuals. As a result, we will be a positive entity to our community, our neighborhood, our city, our state, our country and the world, by encouraging a safer and more respectful environment in which we live.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distribution to organization that qualify as exempt organizations under section 501© 3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

In the corporation should decide to dissolve, Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
