Article One

The name for the corporation is. NEW MT PLEASANT CHILDREN OF DESTINY MINISTRIES INC.

ARTICLE TWO

The principal place of business and the mailing address of this corporation shall be 6132 Flicker Ave, Jacksonville FL. 32218

ARTICLE THREE

The general purposes for which this corporation is formed are to interpret and expound the Holy Bible; to maintain it as the foundation of all spiritual truth; to establish churches; to ordain ministers of the Gospel, authorized by it to teach and minister unto its members, and the community. Through Grants, Donations and Charitable contributions this corporation regardless of race or creed, shall provide the following services to any qualifying applicant housing, transportation, and or purchase vehicles to give to those in need of transportation, to have a food pantry pay deposit for lights, rent, water or gas.
