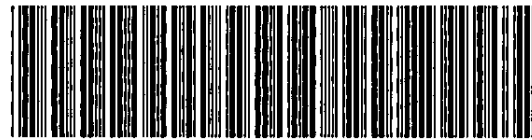



ARTICLE VIII: OWNERSHIP


