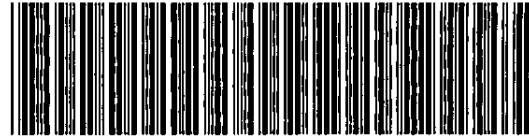




ARTICLE VIII: OWNERSHIP
