**ARTICLES OF INCORPORATION
OF**

PROCLAIM RADIO, INC.

(A FLORIDA CORPORATION NOT FOR PROFIT)

In order to form a corporation under and in accordance with the provisions of the laws of the State of Florida for the formation of corporations not for profit, Chapter 617, Florida Statutes, we, the undersigned, hereby associate ourselves into a corporation for the purpose and with the powers hereinafter mentioned.

**ARTICLE I
CORPORATE NAME**

The name of this corporation is PROCLAIM RADIO, INC.

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and the mailing address of this corporation shall be:

**ARTICLE III
PURPOSES**

The general purposes of the corporation are as follows:

(a) To share and spread the Living Gospel of Jesus Christ through authentic and relevant teaching from the Holy Bible for the benefit of all people.

(b) To do any and all things and exercise any and all powers, rights and privileges which a Florida corporation not for profit may now or hereafter be organized to do under the Florida Not For Profit Corporation Act or any Act amendatory thereof, supplemental thereto, or in substitute thereof.

(c) The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of §501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

(d) Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under §501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The powers, business and affairs of the corporation shall be managed by and directed by the Board of Directors in accordance with these Articles of Incorporation and the Bylaws. This corporation shall have not less than three (3) directors initially. The number of directors may be increased or diminished from time to time by the Bylaws. ARTICLE VIII
NON PROFIT NATURE AND DISTRIBUTION
OF ASSETS UPON DISSOLUTION

This corporation is not organized for a pecuniary profit. It shall not have any power to issue certificates of stock or declare dividends, and no part of its receipts shall inure to the benefit of any member, director, or individual. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of §501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX
AMENDMENT

These Articles may be amended in the manner provided by law.


