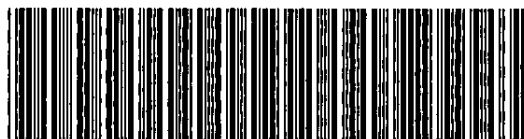



ARTICLES OF INCORPORATION

(Not for Profit)

OF

Ministry of Reconciliation Jacksonville, Inc.

Article I – Name

The name of the Corporation shall be Ministry of Reconciliation Jacksonville, Inc.

Article II – Principal Office

The physical address and mailing address of the principal office of the corporation is:-- --

10334 Triple Crown Avenue
Jacksonville, Florida 32257.

Article III - Purpose

The organization's purpose is to serve as a religious ministry in the Christian faith, to glorify God and proclaim the glorious Gospel of the Lord Jesus Christ to precious souls in Jacksonville, Florida, to edify the saints, and to encourage, equip, and train other believers in the ministry of reconciliation in Jacksonville, Florida and in China. All activities and functions of the organization will be carried out with the objective of furthering the foregoing purposes.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
