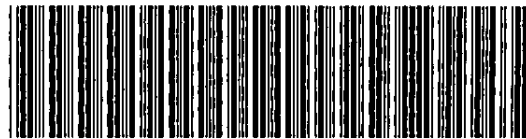

The undersigned incorporator, for the purposes of forming a Not for Profit corporation in compliance with Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of the corporation shall be:

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

The Corporation is organized exclusively for the purpose of being a public charity to promote the sports of baseball and softball, disseminate knowledge and application of the rules of baseball and softball scorekeeping, and to benefit the community by furthering the tradition of family enjoyment of baseball and softball, under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

ARTICLE IV – MANNER OF ELECTION

The Directors of the Corporation shall elect their successors.

ARTICLE VIII – CHARITABLE ORGANIZATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX – DEDICATION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
