

ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME OF THE CORPORATION

The name of this corporation shall be Blue Lagoon Society, Inc.

ARTICLE III EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV GENERAL NATURE OF BUSINESS

Blue Lagoon Society, Inc. is an organization whose purpose is to organize and promote projects for cleaning up, and for preventing future pollution of the estuaries and canals associated with the St. Lucie River in Florida and for any other related, lawful tax exempt purpose.
