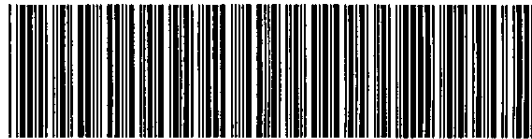

The purpose of the corporation is: THE AFRICAN-AMERICAN ADVOCACY CENTER FOR PERSONS WITH DISABILITIES ("AAACPD") HAS BEEN ORGANIZED TO PROMOTE AWARENESS OF DISABILITIES AND SERVICES AMONG THE AFRICAN AMERICAN COMMUNITY; PROVIDE ADVOCACY; AND ACCESS TO AFRICAN-AMERICANS WITH DISABILITIES. AAACPD IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(C) 3 OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

ARTICLE VII

The corporation shall be dissolved by: THE CORPORATION MAY VOLUNTARILY DISSOLVE AND CEASE TO OPERATE UPON THE AFFIRMATIVE VOTE OF NOT LESS THAN NINETY PERCENT (90%) OF THE DIRECTORS AT ANY MEETING OF THE BOARD, PROVIDED ALL DIRECTORS HAVE BEEN NOTIFIED OF THIS PURPOSE. UPON DISSOLUTION, ANY NET ASSETS OF THE CORPORATION SHALL BE DISTRIBUTED IN ACCORDANCE TO ANOTHER NON-PROFIT ENTITY WITH A SIMILAR PURPOSE.
