The undersigned hereby organizes a not for profit corporation under the provisions of the 3 Florida Not For Profit Corporation Act, and pursuant to the following Articles of Incorporation:

#### ARTICLE 1

#### Name

The name of the corporation is Henderson Family Foundation, Inc., (hereinafter the "Corporation").

#### ARTICLE 2

#### Principal Office and Mailing Address

The address of the principal office and the mailing address of the Corporation is 1511 N. Westshore Boulevard, Suite 700, Tampa, Florida 33607.

#### **Purpose**

#### Indemnification

### **ARTICLE 13**

#### Distribution of Assets Upon Liquidation

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for exempt purposes within the meaning of 501(c)(3) or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE 14

#### Avoidance of Private Foundation Taxes

The Corporation is prohibited from engaging in any act of self-dealing, from retaining any excess business holdings, from making or retaining any investments, and from making any taxable expenditures, that would subject the Corporation or any person to tax under Sections 4941(d), 4943, 4944, or 4945(d) of the Internal Revenue Code of 1986, as amended, respectively, or corresponding H14000259231

provisions of any subsequent federal income tax law. The corporation shall make distributions at such time and in such manner as not to subject it to tax under Section 4942 of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal income tax law.

#### **ARTICLE 15**

#### Amendment to Articles

These Articles of Incorporation may be amended by the board of directors of the Corporation.
