

#### **EXHIBIT "A"**

This Amendment to the Articles of Incorporation ("Amendment") is made this 12th day of December, 2017 ("Amendment Effective Date"), by Clear Lake Landing Homeowners' Association, Inc., a Florida not-for-profit corporation ("Association"), whose address is 1750 W. Broadway, Suite 111, Oviedo, Florida 32765.

#### RECITALS

- A. WHEREAS, on or around November 20, 2014, the Association filed its Articles of Incorporation ("Articles") with the Florida Secretary of State incorporating the Association.
- B. WHEREAS, the Association desires to amend Article 8, Section 1 of the Articles, which addresses the number of Directors on the Board of the Association.
- C. WHEREAS, the Association desires to amend Article 8, Section 2 of the Articles, which addresses the term of a Director on the Board of the Association.
- **NOW, THEREFORE,** pursuant to the powers granted to the Board of Directors of the Association by the terms of the Declaration, the Articles, and Florida Statute, the Association hereby amends the Articles as follows:
- 1. Recitals. The foregoing recitals are true and correct and, by this reference, are hereby incorporated into this Amendment.
- 2. <u>Amendment to Article 8, Section 1</u>. The following sentence is added to the end of Article 8. Section 1 of the Articles:
  - "In all events, the affairs of the Association shall be managed by a Board of no more than five (5) Directors."
- 3. Amendment to Article 8, Section 2. The first sentence of Article 8, Section 2 of the Articles is deleted, and the following language is inserted in its place:
  - "Directors shall be appointed to serve for a one (1) year term, unless a Director sooner dies, resigns or is removed."
- 4. <u>No Further Amendments</u>. In the event of any inconsistencies between the terms and provisions of this Amendment and the terms and provisions of the Articles, the terms and provisions of this Amendment shall control. Otherwise the Articles are unmodified and remain in full force and effect.
- 5. <u>Effective Date</u>. This Amendment shall become effective on the Amendment Effective Date.
