CONFLICT OF INTEREST POLICY

SECTION 1. PURPOSE:

St. Luke New Generation Holiness Church, Inc. is a nonprofit, tax-exempt organization. Maintenance of its tax-exempt status is important both for its continued stability and for public support. Therefore, the IRS as well as state regulatory and tax officials view the operations of **St. Luke New Generation Holiness Church, Inc.** as a public trust, which is subject to scrutiny by and accountable to such governmental authorities as well as to members of the public.

Consequently, there exists between **St. Luke New Generation Holiness Church, Inc.** and its board, officers, and members and the public a fiduciary duty, which carries with it a broad and unbending duty of loyalty and fidelity. The board, officers, and members have the responsibility of administering the affairs of this church honestly and prudently, and of exercising their best care, skill and judgment for the sole benefit of **St. Luke New Generation Holiness Church, Inc.** Those persons shall exercise the utmost good faith in all transaction involved in their duties and they shall not use their positions with this church or knowledge gained there from for their personal benefit. The interest of the organization must be first priority in all decisions and actions.

SECTION 2. PERSONS CONCERNED:
