

CONFLICT OF INTEREST POLICY

SECTION 1. PURPOSE:

St. Luke New Generation Holiness Church, Inc. is a nonprofit, tax-exempt organization. Maintenance of its tax-exempt status is important both for its continued stability and for public support. Therefore, the IRS as well as state regulatory and tax officials view the operations of St. Luke New Generation Holiness Church, Inc. as a public trust, which is subject to scrutiny by and accountable to such governmental authorities as well as to members of the public.

Those persons shall exercise the utmost good faith in all transaction involved in their duties and they shall not use their positions with this church or knowledge gained there from for their personal benefit.
