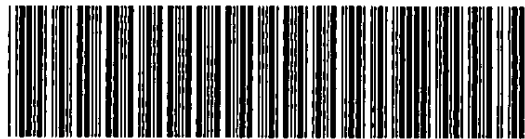

# ARTICLES OF INCORPORATION

## **Article I Name**

The name of the corporation shall be: Salt and Light Foundation Inc.

## **Article II Principle Office**

## **Article III Purpose**

The corporation, Salt and Light Foundation Inc., is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specifically, Salt and Light Foundation Inc. is a not for profit organization whose purpose is to make days better and brighter for those with mental health disorders. The corporation is organized to provide support, education, fundraising and donations, greater opportunity, and awareness, to and for the benefit of individuals afflicted with mental health disorders in Lake County, Florida, the state of Florida, the United States, and throughout the globe. All contributions and assets of the corporation will ultimately and permanently be used to either support other non-profit organizations that are dedicated to serving those with mental health disorders or will be used to provide awareness and support to individuals and communities in whom mental health disorders are present.

## **Article IV Manner of Election**

The manner in which the directors are elected and appointed: Initial directors are identified in the articles of incorporation. After incorporation, the manner in which directors are elected and appointed will be with a 60% or greater majority vote by the existing directors.

## **Article VI Limitations**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or

otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article VII Dissolution Clause**

Dissolution of said corporation shall only occur after receiving a 2/3's supermajority vote by the existing directors of the corporation during a special meeting for said purpose of dissolution. At this time, all remaining assets of Salt and Light Foundation Inc., after full payment of all debts, obligations, outstanding dues and balances, and necessary final expenses, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, to such tax-exempt organizations (with similar purposes to those of Salt and Light Foundation Inc.) chosen by the existing board of directors, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
