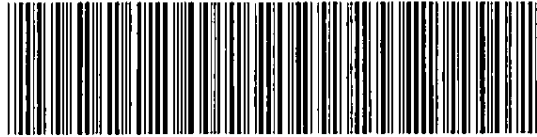

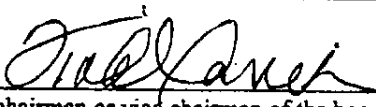

## Articles of Incorporation of

### **BEAUTIFUL BEGINNINGS CHILD CARE CENTER, INC**

The undersigned incorporators, who are individuals 18 years of age or older, a majority of whom are citizens of the United States and pursuant to Compliance with Chapter 617, F.S., hereby adopt the following Articles of Incorporation.

#### ARTICLE I – NAME

The Name of the Organization shall be Beautiful Beginnings Child Care Center, Inc.

#### ARTICLE II – PRINCIPAL OFFICE

The principal office of Beautiful Beginnings Child Care Center, Inc., shall be located within or without the City of Daytona Beach, Florida, at:

348 S. Keech Street  
Daytona Beach, Florida 32114

The organization may maintain additional offices at such other places as the Executive Board may designate.

#### ARTICLE III - PURPOSE

Beautiful Beginnings Child Care Center, Inc., is organized exclusively for charitable, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specific Purposes may include, but are not limited to:

- A. Provide a safe, secure, and nurturing learning environment for children of all ages.
- B. Empower, educate and inspire youth through mentoring, teaching, tutoring, etc.
- C. Sponsor, host and/or participate in events, programs, and activities that promote educational enrichment to help assist individuals in realizing their full potential.
- D. Offer services that uphold the ideals, principles, and objectives which may be essential in supporting advancements of the communities throughout Volusia County.
- E. Make facilities and/or equipment available to provide youth with the necessary resources to become confident, thriving, and productive members of their respective communities.

The organization's bylaws shall regulate the conduct and governance of Beautiful Beginnings Child Care Center, Inc.

#### **ARTICLE IV – MANNER OF ELECTION**

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

#### **ARTICLE V – INITIAL DIRECTORS AND/OR OFFICERS**

#### **ARTICLE VI - LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VII – DEDICATION OF ASSETS**

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **ARTICLE VIII – DURATION**

The period of duration of the Florida Corporation named herein is Perpetual.
