

AMENDMENT TO ARTICLES OF INCORPORATION OF BUILDING HOPE HERCULES, INC.

THIS AMENDMENT TO ARTICLES OF INCORPORATION (the "Amendment"), made as of the 8th day of March, 2016, is to be filed on behalf of Building Hope Hercules, Inc. (the "Corporation"), a Florida nonprofit corporation, with the Department of Corporations, Office of the Secretary of State, State of Florida.

WHEREAS, the name of the Corporation is "Building Hope Hercules, Inc."; and

WHEREAS, the Corporation's sole member (100%; the number approving is sufficient to amend the articles of the Corporation) and Board of Directors have both approved an amendment to its Articles (as defined below), by unanimous written consent adopted February 9, 2016, to change its sole member from Building Hope...A Charter School Facilities Fund, to Building Hope Parkside Foundation, its successors and assigns;

NOW, THEREFORE, the Corporation's Articles of Incorporation, filed on December 2, 2014, and amended by a reinstatement document dated September 28, 2015 (collectively referred to as the "Articles") are hereby amended as follows:

1. "ARTICLE IV – MEMBERS" is hereby deleted in its entirety and shall be replaced with the following:

The sole member of the Corporation shall be Building Hope Parkside Foundation, a District of Columbia nonprofit corporation.
