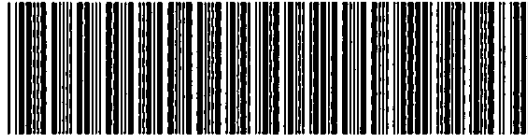

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of incorporation

**ARTICLE I**

**NAME**

The name of this corporation shall be: Favor of God Ministries Church of God In Christ, Inc.

**ARTICLE II**

**Principle place of business and mailing address**

The principle place of business of this corporation shall be:

**ARTICLE III**

**PURPOSE**

The purpose for which the corporation is organized is:

To provide means, facilities, services and all other activity necessary for providing the worship of God by the members of this corporation (church).

**ARTICLE IV**

**Manner of elections of Officers**

The manner in which Officers are elected or appointed is as follows:

The Pastor has all executive powers. The Pastor appoints a Board of Trustees, which is responsible for the execution of the purpose of this corporation both administrative and financial. Members of the corporation elect all other corporation officers.

**ARTICLE V**

**Limitation of corporate power**

As soon as the proposed alterations or amendments shall have been adopted as herein provided, the result of the vote shall be announced by the secretary and declared adopted by the Pastor, and filed with the Secretary of the State of Florida, where upon such alterations or amendments shall be full force and effect.

**ARTICLE VI**

**Church Affiliation**

It is intended that this incorporated Church shall be affiliated with and part of the Church fellowship known as the "Church Of God In Christ" denomination; which has its general headquarters in Memphis, Tennessee, United States of America, and through this affiliation and fellowship adhere generally to the religious dogma, practices and doctrine of said denomination.
