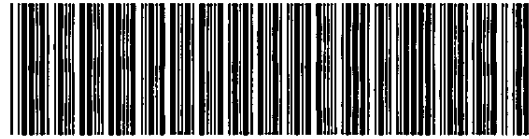

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a non-profit corporation under the Business Corporations Act and other laws of the State of Florida. Effective date of January 1, 2014.

ARTICLE I

The name of the corporation is **ADVOCATES FOR CLIENTS' RIGHTS, INC.**

The corporation shall exist perpetually.

ARTICLE II – PRINCIPAL OFFICE

The principal office of the corporation is: 4347 Habana Avenue, Jacksonville, Florida 32217. The principal office may be moved to any address that the Board of Directors will choose, provided however that the principal office will be in the State of Florida. The mailing address of the corporation shall be the same.

ARTICLE III – PURPOSE

The general nature of the business that will be transacted by the corporation as allowed by Florida Law, will include advocating for the rights of people seeking legal representation. One of the tasks to be tackled includes petitioning the Florida Bar to try and change certain rules, including a current rule which states attorneys may not ethically give loans to clients. This forces clients to take out loans with high interest rates to their detriment. Trying to get legislation passed that will further clients' rights is another purpose of the corporation. Including, but not limited to, legislation dealing with a client's rights to any and all incident reports, which at this time are typically considered "work product" which hinders the ability of clients to receive a

copy of such reports.

The corporation will have the power to invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real property and personal property necessary for the operation of the corporation's business.

The corporation will have the power to do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives for the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendments hereto, and either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes and objects of this corporation.

The foregoing enumeration of objects and purposes will not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE IV – INITIAL OFFICERS AND/OR DIRECTORS

The initial officers and/or number of directors of the corporation shall be two (2). The number of directors may be changed by the bylaw adopted by the shareholders, provided however that the number of directors will never be less than one (1). The initial officers and/or directors are:

No contract or other transaction between this corporation and any other corporation will be affected by the fact that any director of this corporation is interest in or is a director or officer of such other corporation. Every person who may become a director of this corporation is hereby relieved from any liability that might otherwise exist from contracting with this corporation for the benefit of himself or any firm, association, or corporation in which he may be interested in any way.

This corporation shall have the power to entire into, for the benefit of its employees, one or more of the following: (1) a pension plan; (2) a profit-sharing plan; (3) a stock bonus plan; (4) a thrift and savings plan; (5) a restricted stock option plan; (6) health insurance plan; (7) a life insurance plan, or other retirement or incentive compensation plans. This corporation shall have the power to make loans, secured or unsecured, to its shareholders, providing said shareholders are active employees of the corporation.

The corporation shall indemnify any and all persons who may serve or who have served at any time as directors or officers, or who at the request of the Board of Directors of the corporation may serve or at any time have served as directors or officers of another corporation in which the corporation at such time owned or may own shares of stock or which it was or may be a creditor, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts pain in settlement (before or after suit is commenced), actually and necessarily incurred by such person§ in connection with the defense or settlement of any claim, action, suit, or proceeding in which they, or any of them, are made a party or parties, or which may be asserted against them or any of them, by reason of being or having been directors or officers of the corporation, or of such other corporation except in relation to matters as to which any such director or officer or former

director or officer in person will be adjudged in any action, suit, or proceeding to be liable by his own negligence or misconduct in the performance of his duty.
