
**ARTICLES OF AMENDMENT

100 MEN WHO CARE OF MANATEE COUNTY, INC.**



2. The Articles of Incorporation of the Corporation were filed in the office of the Secretary of State of the State of Florida on December 8, 2014.
3. The Articles of Incorporation of the Corporation are hereby amended to reflect the change of the name of the Corporation to UNITED PATRIOT'S ALLIANCE, INC., and the insertion of such name in each and every place in the Articles of Incorporation and Bylaws where the prior name of the Corporation existed.

The above Amendment to the Articles of Incorporation and Bylaws of the Corporation is made by the majority of the Directors of the Corporation in lieu of a meeting of the Members or Board of Directors as permitted by Florida law and the Articles of Incorporation and the Bylaws of the Corporation.
