ARTICLES OF INCORPORATION Of

The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

Article I The name of the corporation is <u>Joseph A. Pesenti & Bernice Fain Pesenti Foundation for</u> Cancer Research, Inc.

Article III The purposes for which the corporation is organized are:

- a. <u>Joseph A. Pesenti & Bernice Fain Pesenti Foundation for Cancer Research, Inc.</u> is organized for exclusively religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986. Specifically, the organization will provide charitable financial distributions to other non-profit organizations for the purposes of supporting research for a cure and treatment options for Cancer.

publication or distribution of statements), any political campaign on behalf of any candidate for public office.
