The New Text for Existing Article #3

The purposes of the Corporation are charitable, educational, or religious, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future Federal tax law ("Section 501(c)(3)"). In furtherance of such purposes, the Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out the purposes, as set forth in the Articles of Incorporation and these Bylaws. The specific purposes of the Corporation are to support local agriculture and healthy communities by providing agricultural education, outreach, and mentoring to families, students, veteran farmers and the community at large; connect consumers with agricultural producers; provide an online marketplace and delivery service to consumers; be an advocate for the local agricultural community; support veteran farming; provide mentoring services, education and farm land to beginning farmers; and promote eco-friendly and best management practices that include, but are not limited to, renewable energy and water preservation."

Amendment #2 Replace existing Article #4 with \

Dissolution of Assets

The Corporation may be dissolved only upon adoption of a plan of dissolution and distribution of assets by the Board that is consistent with the Certificate of Incorporation and with State law. Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes
