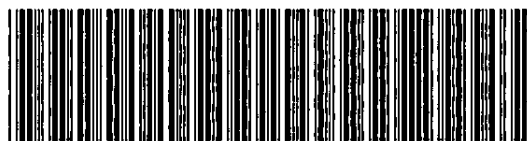

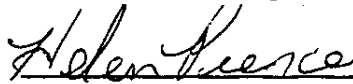

SEVEN:

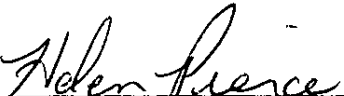
