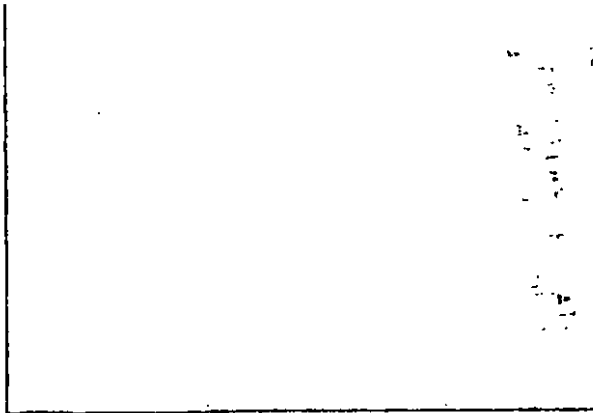

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
THE HIGHLANDS RESERVE COMMUNITY ASSOCIATION, INC.**

WHEREAS, the Articles of Incorporation of The Highlands Reserve Community Association, Inc. (hereinafter the "Articles") were originally filed with the Department of State on December 15, 2014 and were recorded in Official Records Book 23030, Page 1586 of the Public Records of Hillsborough County, Florida;

WHEREAS, Section 12.3 of the Articles provides that the Articles may be amended by the affirmative vote of majority of the Board and not less than fifty-one percent (51%) of the Association's voting interest present in person or by proxy at a duly-called and noticed meeting of the members;

NOW THEREFORE, we, CHARLES E. HERRMANN, as President, and KRISSY PERKINS, as Secretary of The Highlands Reserve Community Association, Inc. (hereinafter the "Association"), hereby certify that at the annual meeting of the members on November 29, 2018, held in accordance with the By-Laws of The Highlands Reserve Community Association, Inc., the following amendments to the Articles were approved by a majority of the Board and not less than fifty-one percent (51%) of the voting interest present in person or by proxy at said meeting:

I. Article 9 of the Articles of Incorporation of The Highlands Reserve Community Association, Inc. is amended to read as follows:

9. Board of Directors. The affairs of the Association shall be managed by a Board of ~~odd~~ number with not less than three (3) or more than five (5) members. ~~The initial number of Directors shall be three (3).~~ Directors must be members of the Association. Board members shall be appointed and/or elected as stated in the Bylaws. ~~After the Turnover Date, (The election of Directors shall be held at the annual meeting. Each Director shall serve for a term of two (2) years on a staggered basis, or until such time as his or her successor is chosen. In order to establish a five (5) member Board with staggered terms, there shall be five (5) Director positions open for election at the annual meeting of the members following the recording of this amendment in the public records. The three (3) candidates receiving the highest number of votes at the annual meeting of the members shall serve two (2) year terms. The two (2) candidates receiving the next highest number of votes at the annual meeting shall serve one (1) year terms. Thereafter, each elected Director shall serve a two (2) year term. The names and addresses of the members of the first Board who shall hold office until their successors are appointed or elected, or until removed, are as follows:~~

14. Officers. The Board shall elect a President, Vice President, Secretary, Treasurer, and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall from time to time determine. ~~The names and addresses of the Officers who shall serve until their successors are elected by the Board are as follows:~~
