#### ARTICLES OF AMENDMENT

TO

#### ARTICLES OF INCORPORATION

OF

#### TORAHLIFE MINISTRIES, INC.

The undersigned, acting as incorporators of this Corporation pursuant to Chapter 617 of the Florida Statues, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

#### **PREAMBLE**

For the more certain preservation and security of the principles of our faith, and to the end that this body may be governed in an orderly manner and for the purpose of preserving the liberties inherent in each individual member of this religious organization and the freedom of action of this body with respect to its relation to other religious organizations of the same faith, we do declare and establish this as the Constitution and Charter of the Ministry.

# ARTICLE I NAME OF CORPORATION

The name of the Corporation shall be TORAHLIFE MINISTRIES, INC.

#### **ARTICLE II**

#### ADDRESS OF PRINCIPAL OFFICE AND MAILING ADDRESS OF CORPORATION

The address of the principal office of the Corporation is 4008 Castell Drive, Orlando, FL 32810-1902 and the mailing address of the Corporation is the same 4008 Castell Drive, Orlando, FL 32810-1902 and it is located in the County of Orange.

## ARTICLE III

#### TERM OF EXISTENCE

The Florida Not-For-Profit Corporation shall have perpetual existence, commencing with the date of execution of the Articles of Incorporation filed with the Florida Secretary of State in December 18, 2014

#### ARTICLE IV

#### PURPOSES AND POWERS OF THE CORPORATION

A. The Corporation is organized exclusively for charitable, educational, scientific and literary opportunities and religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation may receive and administer funds for scientific, educational, and charitable purposes, within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, as amended or such corresponding section of any future federal tax code (hereinafter referred to as the "Code"). To the extent consistent with the preceding sentence and permissible under Florida law, the purposes of this Corporation shall include, but shall not be limited to, the following:

- 1) To Educate Jewish and non-Jewish people who have received Yeshua as the Messiah, print religious publications and books, conferences speaker, broadcast radio, television and internet messages aimed at gathering people from their traditional Christian backgrounds, and educate them about the Jewish Messiah.
- 2) To support, assist and educate into Jewish life, Jewish history, Jewish traditions, and Jewish religious activities and observances.
- 3) To teach the good news of Messiah Yeshua to the community and to the nations furthering their understanding and acceptance of Yeshua as the Messiah as foretold by the Jewish scriptures.
- 4) To provide Messianic Jewish education for adults and children and to fully equip them to fulfill the calling of God in their lives.
- 5) To assist worthwhile Jewish causes, whether Messianic of not, by practical deeds.
- B. This Corporation shall be authorized to carry out any and all acts and to exercise any and all corporate powers which may now or hereafter be lawful under the laws of the State of Florida to the extent applicable to corporations not for profit and that are not inconsistent with these Articles of Incorporation.
- C. Notwithstanding anything contained in these articles of Incorporation to the contrary, the following provisions shall apply:
  - 1. No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, directors, trustees, officers, or private persons, (except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the corporation affecting one or more of its purposes) and no director, officer or any private individual shall be entitled to share in the distributions in furtherance of the purposes set forth in this Article IV.
  - 2. No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign (including publishing or distributing statements) on behalf of or in opposition to any candidate for public office.
  - 3. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the code, or (b) by a corporation contributions to which are deductible under Section

- 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax Code.
- 4. The Corporation is organized pursuant to the Florida Non-Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.

#### ARTICLE V

## **DISSOLUTION OF CORPORATION**

Upon the dissolution of this Corporation, after the payment or provision for the payment of all of the liabilities of this Corporation, all of the assets of this Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes. In no event, however, may the assets to be disposed of be distributed to or for the benefit of any member, director, officer or other private person, other than as reasonable payment for services rendered by such person.

#### **ARTICLE VI**

#### **ELECTION OF DIRECTORS**

- A. The Board of Directors of the Corporation shall be elected as provided in the Bylaws. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of this Corporation, but shall never be less than three (3).
- B. The actual number of directors of this Corporation is six (6). The names and addresses of those members of the Board of Directors are:
