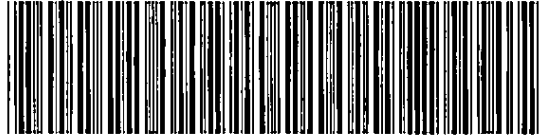

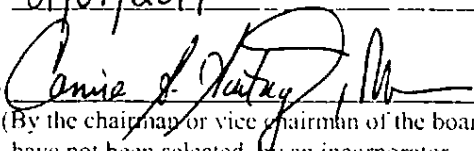

FINAL JUDGMENT OF ADULT CHANGE OF NAME

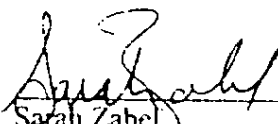
