This Corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501 (c)(3) exempt organizations.

- 1- No part of the net earnings of the organization shall inure to the benefit of, or be distributable to any members, trustees, officers, or other private persons, excepting solely such reasonable compensation that the organization shall pay for services actually rendered to the organization, or allowed by the organization as reasonable allowance for authorized expenditures incurred of behalf of the corporation.
- 2- No substantial part of the activities of the organization shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public and the organization shall not participate in, or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3- Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, as now enacted or hereafter amended.
- 4- This organization shall not lend any of its assets to any officer or director of this organization, or guarantee to any person the payment of a loan by an officer or director of this organization.
- 5- Upon the time of dissolution of the organization, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, cost and expenses of the organization, for one or more exempts purposes within the seaming of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distribute to the federal government, or to state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes for to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
