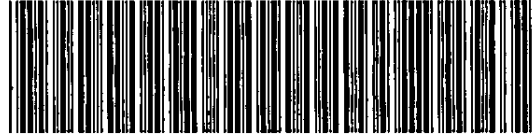

**CERTIFICATE OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF  
EVERGREEN AT PT. ST. LUCIE CONDOMINIUM, INC.**

The Articles of Incorporation of Evergreen at Pt. St. Lucie Condominium Association, Inc. were filed with the Florida Secretary of State on April 12, 1986. The same Articles of Incorporation were recorded in Official Records of St. Lucie County, Florida at Official Records Book 503, Page 2982, et. seq. The same Articles of Incorporation are hereby amended as adopted by the Board of Directors at a duly convened Board Meeting and by the membership by a vote sufficient for approval.

**ARTICLE 6**

**DIRECTORS**

1. Article 6 is amended to read as follows:

6.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) directors. Directors must be members of the Association.

(The balance of Article 6 remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of Evergreen at Pt. St. Lucie, A Condominium was adopted by the Board of Directors at a duly convened Board Meeting and by the membership by a vote sufficient for approval.
3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
4. All provisions of the Articles of Incorporation of Evergreen at Pt. St. Lucie, A Condominium are herein confirmed and shall remain in full force and effect, except as specifically amended herein.

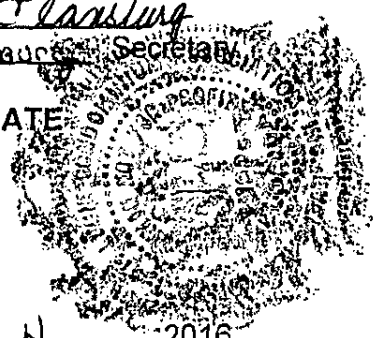
