

FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF INDIAN WELLS OSCEOLA COUNTY HOMEOWNERS' ASSOCIATION, INC.

Article VI is hereby amended as follows:

ARTICLE VI

MEETINGS OF MEMBERS: QUORUM REQUIREMENTS

The presence at any meeting of members entitled to cast, or of proxies entitled to cast, a majority of the votes ten (10%) percent of the total membership shall constitute a quorum for any action except as otherwise provided in these Articles of Incorporation, or the Bylaws.

Article VIII is hereby amended as follows:

ARTICLE VIII

BOARD OF DIRECTORS

The affairs of this Association shall be managed initially by a Board of three (3) directors who shall serve until the organizational meeting and thereafter by a Board of three (3) Directors, who need not shall be members of the Association.
