ARTICLE II, NATURE OF BUSINESS, (a): SENTENCE ADDED: Additional business of the church is also outlined in the church's Bylaws and Constitution, and other written established policies developed to maintain good order within the church.

ARTICLE III, MEMBERSHIP (paragraph added): Other requirements for membership are included in the church's Bylaws and Constitution. Anyone desiring to establish membership with New St. Lewis shall be bound by the rules as set forth in these Articles of Incorporation (as amended) and written Bylaws, Constitution, statements of belief, and other established policies, written to establish good order within New St. Lewis. Church membership may be terminated as outlined in New St. Lewis Bylaws and Constitution and any written policies established to maintained good order within the church.

ARTICLE V, TRUSTEES: as read "The Corporation shall have as its directing board of directors trustees of not less than five (5) in number. The number of Trustees may be increased or decreased at any time by the bylaws but the number of trustees shall never be less than five."

is changed to read "The Pastor and Trustees of the corporation shall be the Corporation's Board of Directors. The number of directors of the corporation shall be not less than five nor more than seven. The number of trustees shall never be less than three. The number of trustees may be increased or decreased at any time in accordance with the procedures as outlined by the church's Bylaws and Constitution."

ARTICLE VII, DUTIES OF TRUSTEES: Paragraph (c) added: Trustees must be aware of and provide for the upkeep of the church building which encompasses inside and outside maintenance of the church and church property.

ARTICLE X, CORPORATE OFFICERS (a): As reads "The President (Pastor) shall at times simultaneously occupy the office of the Chairman of the Board. In addition to his duties as Pastor, the President's only other authority in the capacity of President shall be the power to execute in behalf of the church instruments requiring execution by the church when the execution thereof has been authorized as provided in the Articles of Incorporation and Bylaws and Constitution"

is changed to read "The President (Pastor) shall also occupy the office of the Chairman of the Board. In addition to his duties as Pastor, the President's authority in the capacity of President shall include

the power to execute in behalf of the church instruments requiring execution by the church when the execution thereof has been authorized as provided in the Articles of Incorporation and Bylaws and Constitution. Other duties and responsibilities may be required as outlined in the church's Bylaws and Constitution and other written established policies of the church."
