AMENDMENT TO THE ARTICLES OF INCORPORATION OF CARMEL AT THE CALIFORNIA CLUB CONDOMINIUM "24" ASSOCIATION, INC.

ARTICLE IX

DIRECTORS

§9.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a Board consisting of the number of directors determined in the manner provided by the By-Laws but which shall consist of not less than three (3) directors. The member and qualification of individuals to serve on the Board of Directors shall be as set forth in the By-Laws, as it may be amended from time to time.
