The purpose for which this company is organized is:

Exclusively for charitable, religious, educational, scientific, literary, as well as any and all lawful purposes that support and partner with **Gratitude House, Inc.** in its mission to help women and babies in recovery from matters pertaining to substance abuse and transition, that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE IV - Manner of Election:

As shall be provided for in the By Laws of the Corporation.

#### **ARTICLE V. Public Benefit**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation,

and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
