The Corporation was duly organized on January 1, 2015 as a Florida Not for Profit Corporation pursuant to Articles of Incorporation which were duly filed with the Florida Secretary of State on that date. Pursuant to Chapter 617.1006; Florida Statutes (Not for Profit), the Articles of Incorporation of the Corporation are hereby amended and restated in full as follows:

## ARTICLE I NAME

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.
