Articles of Incorporation

Article I Corporate Name

The name of the corporation shall be:

BBT ONLINE MINISTRY, INC.

Article II Principal Office

The corporation's principal place of business and mailing address shall be:

13921 NW 146th Avenue
Alachua, FL 32615

Article III Organization and Purpose

Generally

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specifically

To minister to a worldwide Internet audience the teachings of Lord Krishna as taught in the Bhagavad-Gita As It Is, Srimad-Bhagavatam, Chaitanya Charitamrita and related Vaishnava scriptures, as given to us by our spiritual master, His Divine Grace A.C. Bhaktivedanta Swami Prabhupada, Founder-Acharya of the International Society for Krishna Consciousness. We will establish and maintain an online Internet presence through Internet websites, blogs, apps, online radio and video broadcasts, email newsletters, e-books, audio books, live and on-demand streaming and downloads, and any relevant methods of content delivered over the Internet that may be developed in the future.

To facilitate the online Internet distribution of spiritual literature published by the Bhaktivedanta Book Trust (BBT), in both digital and physical printed form.

Our spiritual principles and precepts are those of the International Society for Krishna Consciousness, and are as follows:

1. To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world.
2. To propagate a consciousness of Krishna as it is revealed in the Bhagavad-Gita and Srimad Bhagavatam.
3. To bring the members of the Society together with each other and nearer to Krishna, the prime entity, and thus to develop the idea, within the members, and humanity, at large, that each soul is part and parcel of the quality of Godhead (Krishna).
4. To teach and encourage the Sankirtan movement of congregational chanting of the holy name of God as revealed in the teachings of Lord Sri Chaitanya Mahaprabhu.
5. To erect for the members, and for society at large, a holy place of transcendental pastimes, dedicated to the personality of Krishna.
6. To bring the members closer together for the purpose of teaching a simpler and more natural way of life.
7. With a view towards achieving the aforementioned purposes, to publish and distribute periodicals, magazines, books and other writings.

Article IV Election of Directors

The corporation has no members. Directors are elected at the time and place and by the process specified in the corporation's by-laws. A Director holds office as specified in the corporation's by-laws.

Article VI Corporate Existence

The duration of the corporation shall be perpetual.

Article VII Limitations on Corporate Powers

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth in these Articles of Incorporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII Dedication and Distribution of Assets

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. In the first instance, such assets shall be distributed to Back To Godhead, Inc., a Pennsylvania Not-for-Profit corporation (EIN: 23-2428595) registered as a Foreign Non Profit Corporation in Florida (Document No. F01000004531). Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
