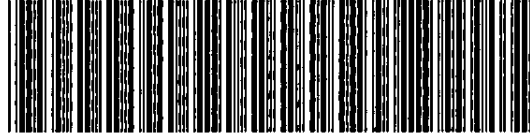

NONPROFIT CORPORATION ARTICLES OF INCORPORATION

Pursuant to §617 of the laws of Florida, the undersigned majority of whom are citizens of the United States, do hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation.

ARTICLE 1

Name

The name of the corporation is Sarasota Community Rowing Association, Inc.

ARTICLE 2

Corporation Address

The principal place of business and mailing address of the corporation is:

ARTICLE 3

Purpose

The purpose of Sarasota Community Rowing Association is to represent its two member organizations: the Sarasota County Rowing Club and the Sarasota Scullers Youth Rowing Program regarding interactions with various entities that could include, but are not limited to: governmental bodies (e.g., Sarasota County), neighborhood associations near Blackburn Point (e.g., Casey Key Homeowners Association), and the media to promote rowing at Blackburn Point Park in Osprey, Florida. A primary example of Sarasota Community Rowing Association, Inc.'s purpose is to negotiate a facilities use lease agreement with Sarasota County on behalf of Sarasota County Rowing Club and Sarasota Scullers Youth Rowing Program.

ARTICLE 4

Members

The corporation will have two members: Sarasota County Rowing Club and Sarasota Scullers Youth Rowing Program. Each Member shall have one vote. Any decision requiring Members' approval requires the unanimous vote of the Members. Decisions reserved to the Members are matters material to the corporation's existence (e.g., merger, dissolution), matters involving any amount of money, and amending these Articles of Incorporation.

ARTICLE 5

Election or Appointment of Directors

The president of each Member will appoint two people to represent the Member as a director of Sarasota Community Rowing Association, Inc. The Directors will serve staggered terms. Each term is two years except the initial term for one director initially appointed by each Member is one year. Appointments will be made by August 1 of each year. All decisions requiring a directors' vote will require a majority vote.

ARTICLE 6

Directors

The corporation will have the following officers: President, Vice President, Secretary, and Treasurer. The role of President shall alternate between a representative of each Member every year. The corporation's initial directors are as follows:


