

Dear Bruce:

As you know, Royal Office Park Management Company, Inc. ("Management Co."), an affiliate of Pebb Enterprises ("Pebb"), is the current manager of the Association. In addition, Pebb's owners, namely Bruce Weiner, Ian Weiner, and the Jared Weiner Declaration of Trust FBO Amanda Weiner (collectively, the "Weiner's," and together with Pebb, hereinafter, the "Pebb Parties"), are officers and Directors of the Association.

The Pebb Parties are no longer owners of any of the Parcels and therefore desire to relinquish control of the Association to the Members. Accordingly, pursuant to paragraph 8 of the Bylaws of the Association, notice is hereby given of the resignation of the Weiner's as officers and Directors of the Association, and Management Co. as manager of the Association, effective August 1, 2019. The Members will be responsible for electing a new Board and appointing a new manager for the Association.

Please note that Management Co. will terminate all agreements for the operation and management of the Association as of July 31, 2019 and reasonably cooperate with the new manager of the Association to effectuate a smooth transition of the Association's affairs.
