

In order to form a corporation under and in accordance with the provisions of Chapter 617, Florida Statutes, the undersigned subscriber is a natural person and competent to contract and hereby make, adopt and subscribe these Articles of Incorporation, to-wit:

ARTICLE I
Name of the Corporation

The name of the Corporation shall be Bookends and Bridges Foundation, Inc., hereinafter referred to as the "Foundation".

ARTICLE II
Address of Principal Office

The mailing address and principal office of the Foundation is 9865 N.W. 25th Terrace, Doral, FL 33172.

ARTICLE III
Purpose of the Foundation

The Foundation is organized exclusively for charitable, literary, educational, spiritual, informational and scientific purposes. Including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

The Foundation's primary focus is to provide education, support and information to its community members, via local schools, teachers, leaders, directors, academies, charter schools, etc. *Fostering an environment of safety and comfort, which provides areas of communications in understanding differences; promoting a societal enlightening of individuals inalienable rights, via all forms media, including but not limited to print, telephonic and electronic communications, etc.;* providing for the dissemination of appropriate information relating to available resources and provide appropriate research techniques and tools to inform and educate communities regarding all forms of intolerance, prejudice, discrimination and bullying and providing for safe haven to those in society who are most vulnerable and disaffected by the various forms of the aforementioned forms of discrimination, including, but not limited to physical violence, emotional abuse, domestic violence, gender bashing, etc., as based upon unfounded, unwarranted and unconscionable attacks, prejudices and discrimination of any definition.

ARTICLE VIII
Term of Existence

The Foundation shall commence existence upon the filing of these Articles of Incorporation with the Department of State of Florida. The term for which this Foundation shall exist shall be in perpetuity, unless lawfully dissolved according to law.

ARTICLE IX
Amendment

These articles may be amended, altered or repealed in accordance with the laws of the State of Florida and the By-Laws of this Foundation shall be made, altered or rescinded by a two-thirds vote of the directors present at any regular or special meeting called for the purpose of a change or amendment thereto, according to law.

ARTICLE X
By-Laws

The initial Board of Directors of the Foundation shall adopt By-Laws consistent with these Articles of Incorporation. Thereafter, the By-Laws may be altered or rescinded by the directors in the manner provided for by such By-Laws. Pursuant to Section 617.0202(d), Florida Statutes, the method of election of directors is as stated in the bylaws. The mailing address and principal office of the Foundation is 9865 N.W. 25th Terrace, Doral, FL 33172.


ARTICLE XI
Prohibitions

Notwithstanding any other provision of these Articles, the Foundation shall not participate in any activities not permitted to be carried on (a) by a Foundation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Foundation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE XII
Liabilities for Debts

Neither the members nor the members of the Board of Directors or officers of the Foundation shall be liable for the debts of the Foundation.


