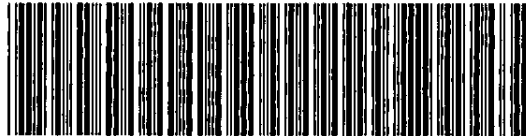

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation shall be Wingspan Foundation, Inc., hereinafter referred to as "the Foundation."

**ARTICLE II
PRINCIPLE OFFICE & MAILING ADDRESS**

The principal office address and mailing address for the Foundation shall be:

**ARTICLE III
CORPORATE PURPOSE**

The Foundation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of any future federal tax code.

**ARTICLE IV
LIMITATION OF CORPORATE ACTIVITY**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the Foundation's corporate purpose as set forth in Article III hereof. No substantial part of the activities of the Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political

campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Foundation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the Foundation's corporate purpose as set forth in Article III hereof.

ARTICLE V DISTRIBUTION OF CORPORATE ASSETS UPON POTENTIAL DISSOLUTION

In the event of the Foundation's dissolution, the Foundation's assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, as the Foundation may determine pursuant to its bylaws. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI ELECTION OF BOARD OF DIRECTORS

The Foundation's directors shall be elected or appointed as set forth in the bylaws.




