Amending the 3rd article to read as follows: Third Article: Said Corporation is organized exclusively for religious, charitable synagogue for religious services and community outreach and for such purposes, the making of distributions to organizations that qualify as exempt orgnaizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The corporation shall further be permitted to engage in any lawful act for which corporations may be organized under the Florida Not For Profit Corporation Act. Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under IRC 501 (c) (3) or corresponding provisions of any subsequent law.


