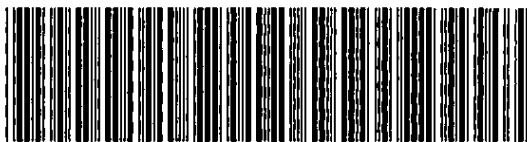

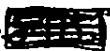

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME OF THE CORPORATION

The name of this corporation shall be The International Solid Rock, Inc.

ARTICLE II PRINCIPAL OFFICE

The address of this corporation is 183 Bella Vista Way, Royal Palm Beach, FL 33411.

ARTICLE III EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV PURPOSE

The purposes for which The International Solid Rock, Inc is organized are exclusively religious, charitable, literary and educational. The purpose is not limited to, but includes the rehabilitation of criminals in the penal institutions and half-way homes through the dedicated interdenominational efforts of Christian men and women. To challenge incarcerated men and women to adopt a personal relationship with God through the Lord Jesus Christ through education, instruction, music, and letter-writing.

The powers of The International Solid Rock, Inc. are limited to those within the scope of section 501(c)(3) of the internal revenue code of 1986 of the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future Federal tax code.

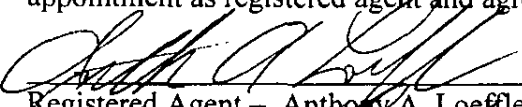
