# ARTICLES OF INCORPORATION

## Article 1.

The name of the Nonprofit Corporation is ManyPaths Animal Rescue, Inc.

# Article 2.

The Nonprofit Corporation is organized pursuant to Chapter 617, F.S. (Nonprofit) of the Florida Statutes, Department of State, State of Florida.

# Article 3.

Terry Griffith is designated as the Nonprofit Corporate representative upon whom process against it may be served. The address within or without this state, to which the Secretary of State shall mail a copy of any process against the Nonprofit Corporation, is to be located at 1445 Spring Lake Road, Fruitland Park, FL 34731

## Article 4.

The Nonprofit Corporation shall exist in perpetuity unless dissolved.

#### Article 5.

The principal office and county within this state in which the office of the Nonprofit Corporation is to be located in is Lake County. The business street address is 1445 Spring Lake Road, Fruitland Park, FL 34731. Mailing address is the same.

# Article 6.

The purpose or purposes for which the Nonprofit Corporation is formed is as follows, to wit:

To provide for the rescue, rehabilitation and adoption of domestic animals throughout Marion, Lake and Sumter Counties initially, with services ultimately provided statewide. To employ such persons as it deems necessary and proper to carry out the operations of the Nonprofit Corporation. To provide other services as may be deemed necessary in the future.

To lease or purchase personal and Real Property, as it deems necessary, to carry on the operations of the Nonprofit Corporation.

To apply for, obtain, purchase or otherwise acquire any patents, copyrights, licenses, trademarks, trade names, rights, processes, formulas and the like, which are or may seem capable of being used for any of the purposes of the Nonprofit Corporation and to use, exercise, develop, grant licenses and franchises in respect of.

## Article 7.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## Article 8.

The manner in which any directors are elected and appointed are stated in the Nonprofit Corporation's By Laws.
