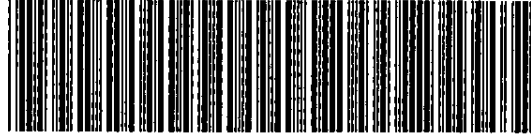

**Article I – Name**

The name of the Corporation shall be GAFBE-SFL, Inc.

**Article II – Principal Office**

The physical address and mailing address of the principal office of the corporation is 8117 Severn Drive, Unit B, Boca Raton, Florida 33433.

**Article III - Purpose**

The specific purpose for which this Corporation is organized is to improve the quality of life for Brazilian families with special needs children who live in the South Florida area. In furtherance of such purpose, the corporation will engage in support and recreational activities among affected families, facilitate information exchanges, solicit and sponsor lectures by specialists, disseminate educational materials, and engage in such other activities that will promote the purposes and objectives as stated herein.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

**Article IV – Manner of Election**

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
